at the undersigned location and date, under the following terms and conditions:

1. The subject of this Agreement is the Parties' collaboration on the international educational and research activities on the highest level related to the Armenian studies, with emphasis on the presentation and research of the Central and Eastern European Armenian history and culture, the historical and cultural sciences linked to Western-Armenian cultural sphere and the study of changes in society.

2. The implementation of subject stated in paragraph One may be done especially in the following terms by the Parties:

- a) mutual exchange of information, regular professional consultation,
- b) development of joint research projects,
- c) development of joint educational projects,
- d) co-organization of events (exhibitions, summer university courses, study tours),
- e) joint application for grants, especially on international tenders,
- f) joint promotion of teaching of Armenian language and culture,
- g) announcement of joint publications of the related professional fields.

3. During the implementation of this Agreement Parties shall cooperate and inform each other of any necessary information related to the activities.

4. Designated contact person for each Party:

Foundation: Dr. Razmik Panossian

GWZO: Professor Stefan Troebst

PPCU: Dr. Bálint Kovács

5. Further activities and details regarding the terms of implementation stated in Paragraph 2 shall be determined and signed in a separate agreement. This Agreement holds the Parties to no financial or other specific commitment.

6. The Parties shall enter into this Agreement for a period of one year, counting from the day of its signature. This agreement may be renewed for successive periods of one year if agreed to by the Parties.

7. The present Cooperation Agreement may be modified by the mutual consent of the Parties, and it may be annulled at six months' notice, by any Party.

8. The Parties stipulate that if any provisions of the present Agreement become void for any reason, or become void due to a subsequent change in the law, this fact shall not result in the total invalidity of the present agreement – except for when it can be clearly established that without the void parts the Parties would not have entered into the present Agreement.


9. The Parties agree to attempt an amicable settlement of any dispute arising in connection with the fulfilment of the present Agreement by means of mutual negotiation.

10. The present agreement was drawn up in English.

By signing the present Agreement, the Parties declare their approval of the document as conforming to their intentions entirely.
