## AGREEMENT ON ACADEMIC COOPERATION between UNIVERSITY OF WARSAW and PÁZMÁNY PÉTER CATHOLIC UNIVERSITY IN BUDAPEST



The University of Warsaw, (hereinafter called UW) with its seats in Krakowskie Przedmieście 26/28, 00-927 Warsaw, Poland and

The Pázmány Péter Catholic University (hereinafter called PPKE), with its seats in Szentkirályi u. 28, 1088 Budapest, Hungary

recognizing the value of scientific cooperation and academic exchange agree to the following:

- a. develop joint research activities;
- b. invite each other to participate in seminars and conferences organized by the respective institution;
- c. organize joints events (conferences, exhibitions, study tours, etc.);
- d. support mutual visits by faculty members and research associates;
- e. organize an academic exchange between the MA students;
- f. spend one semester at the cooperating Party's university in the frame of the academic exchange between the Parties;
- g. implement joint educational programs;
- h. reciprocal exchange of information, and regular professional consultations;
- i. list each other as partners on the Parties' website;
- j. exchange scientific information, publications and other results of teaching and research.

§ 1

- 1.1 The following units will be engaged in cooperation:
  - on the part of the University of Warsaw: Centre for East European Studies, Faculty of Oriental Studies;
  - on the part of the Pázmány Péter Catholic University University: Faculty of Humanities and Social Sciences.
- 1.2 The UW designates herein Mgr. Jan MALICKI, Centre for East European Studies, Faculty of Oriental Studies, as a coordinator and a contact person with regard to implementation of the present Agreement.
- 1.3 The PPKE designates herein Dr. Sándor ŐZE, Faculty of Humanities and Social Sciences as a coordinator and a contact person with regard to the implementation of the present Agreement.

§ 2

- 2.1 The terms of collaboration for each specific activity implemented under this cooperation Agreement shall be discussed mutually and agreed in writing by both Parties prior to the initiation of that activity.
- 2.2 The Parties undertake to get students familiar with the historical and cultural connections of Central Europe.
- 2.3 All financial resources shall be regulated on a case-by-case basis. Given the general restrictions on the budgets, the partners shall endeavor to raise funds from outside sources. In view of this neither Party assumes any prior financial obligations. The Parties understand that in any case the execution of all joint activities will depend on the availability of funds. The present Cooperation Agreement does not impose Parties with any financial or other specific commitment.

- 3.1 Neither the University of Warsaw nor the Pázmány Péter Catholic University will be held responsible for any liability. Furthermore, neither Party shall be required to purchase any insurance against loss or damage to any personal property to which this Agreement relates.
- 3.2 The participants of the exchange shall cover the costs of health and accident insurance for the period of their stay in the receiving country.

§ 4

- 4.1 This Agreement is effective as of the date of execution by the appropriate legal representatives of each signatory institution. It shall remain in effect for five (5) years. Both parties shall review the status of the Agreement at the end of a 4 (four) year period to determine any modification that might be necessary. Depending on the outcome of the evaluation, the Parties will decide whether to extend this Agreement for another period of 5 (five) years.
- 4.2 Any changes, modifications or amendments to the Agreement shall be null and void unless made in writing.
- 4.3 Either Party may terminate this Agreement earlier by written notice. Such notification must be given at least ten months in advance of the effective date of termination. In such case both Parties will take the necessary measures until the actions in process will be finished.
- 4.4 This Agreement is signed in good faith and in accordance with the administrative rules and procedures governing each Party. Therefore any conflict that may arise with respect to its interpretation, formalization, and fulfilment will be resolved by agreement between the Parties.
- 4.5 The Agreement is written in three original copies in English, two for the PPKE and one for the UW.
