1. The general purpose of this agreement is to establish and facilitate educational and academic exchanges between the Police Academy of the Czech Republic in Prague and the National University of Public Service in order to support their students/participants and teachers in mutually gathering and exchanging academic and professional experience in their respective institutions.

Additionally, this agreement is intended to describe the nature and the guidelines for a mutually beneficial cooperation.

- 2. The two institutions agree to promote mutually beneficial activities in the areas of education, research and other academic issues and to cooperate in these areas. Such cooperation may include but is not limited to:
 - exchange of students and lecturers,
 - exchange of publications,
 - exchange of professional experiences,
 - joint research projects,
 - joint conferences,
 - organisation of programmes for the professional community.
- 3. This agreement does not establish the financial obligations of the parties. Specific forms of cooperation are implemented on the basis of independent agreements between the parties concluded in accordance with the law. The European Commission has approved the Public Administration and Civil Service Development Operational Programme (hereinafter: KÖFOP) in its decision C (2015) 5262, furthermore the Hungarian Government has established the annual development framework of KÖFOP in its decision 1004/2016 (I. 18.) related to the annual development framework of the Public Administration and Civil Service Development Operational Programme. Annex No. 2 of the Government decision has designated the project "Public service development establishing good governance" (KÖFOP-2.1.2-VEKOP-15) (hereinafter referred to as: Project) a priority project, the beneficiary of which is the National University of Public Service. The National University of Public Service agrees to examine the compliance to the objectives of the Project and the financing possibilities at the expense of the Project budget of the activities planned to be realized in cooperation of the Parties under the present agreement during the Project implementation period set out in the Grant Agreement of the Project. Financing of such joint activities shall be regulated in separate agreements.
- 4. This agreement commences on the date of signature and remains in force for 5 (five) years in the first instance. It will come to an end after the definite period has expired if the Parties don't agree upon its extension before its expiry date. This agreement can be

terminated by the end of an academic year by giving 30 days' notice at least. If this agreement is terminated, all engagement prior to the date of termination must be performed.

This agreement has been signed in six counterparts, one for each Party in the Czech, Hungarian, and English languages, whereas each version has the same legal force. In case of any conflict of interpretations, the English text will prevail.
